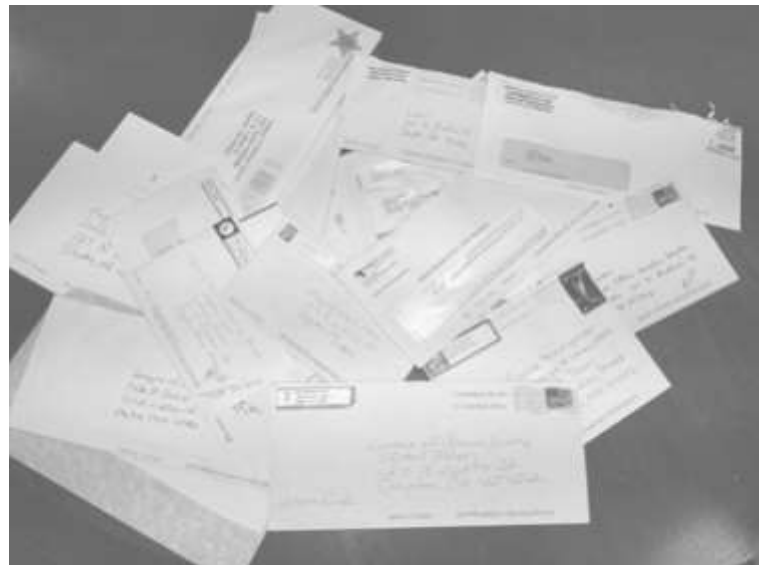

## From the President's Desk

Thank you very much to the 80 members who sent in their annual meeting ballots in May and June! It was truly a record turnout. All items on the ballot passed, most unanimously. While we have several returning Board members, we are pleased to welcome Michelle Arostegui in the position of Secretary.

Your votes also approved the proposed bylaws change which will allow us to call an additional membership meeting if necessary to change our bylaws (outside of the annual meeting). The League Fund budget for 2020-21 was approved by membership, and the Education Fund budget was approved to be sent to the Education Fund trustees, who met at the end of June and approved their budget.

Your 2020-21 Board of Directors will be meeting via Zoom for the foreseeable future. While we are not meeting in person, we continue to do the good work of the League of Women Voters.

- Our League partnered with PBS Think TV with a virtual screening and panel discussion of *The Vote*, a four hour documentary in two episodes from PBS American Experience. League members Val Lee and Dianne Herman represented our League fabulously, discussing the suffrage movement. If you missed the opportunity to see the event, it is available to stream on the Think TV website, **ThinkTV.org**.
- We welcomed two new interns, Emma Klemmensen and Paige Wright, to advance voter registration and education to youth in our area through social media. These interns are working with our Community Relations team.
- Several of our Board members represented the Dayton League at the first ever virtual LWVUS national convention. I was impressed by the many congratulatory videos from VIPs and members of Congress and the inspiring keynote address from CBS News anchor Norah O'Donnell. - The Community Relations team has begun a "Stand with League" campaign on our social media, where we are reaching out to our members, friends, and community to ask for monetary support for the Education Fund. - We held our first virtual New Member Welcome via Zoom at the end of June and plan to hold our first virtual Funding & Development event in August (see related article on page 6).

## PASSING THE BATON

Kathy Farmer and Sandy Nearing are each retiring from roles they have long held with the League.



Kathy has represented the League at Naturalization Ceremonies for more than ten years. She has welcomed thousands of people as new citizens, explaining the process of voter registration and the role of the League of Women Voters. She has invited other League members to witness the process and to learn to represent the League at these very special proceedings, ensuring someone from the League attends each ceremony and coordinating the schedule with the Naturalization Deputy of the US District Court. Wendy Dyer is stepping into this role, and will keep volunteers apprised when the courts allow the public back into the courtroom. Wendy is adding this new responsibility to her current job of coordinating voter registration at naturalization ceremonies.

Sandy has represented the League on the Montgomery County Sanitary Engineering Department Appeals Board for at least 15 years. She has enjoyed this job, which she describes as detective work. She reads the information provided by the county, listens to the appeals of residents who have unresolved disagreements with the sanitation department, then comes to a verdict with two other Appeals Board members. Paul Lamberger, Co-Director of the Natural Resources Committee, will step into this seat when Sandy's term is up in August 2020.

The League is grateful to Kathy and Sandy for their years of service. We wish them well in their new ventures as we look forward to new ways they may engage with the League!

### DO ONE THING: Register New Voters!

Jo Lovelace Hill, VP of Voter Services, needs our help. COVID-19 has dramatically reduced opportunities for Voter Registration and distribution of absentee ballot applications. But, with everyone's help we can make a big difference in Montgomery and Greene Counties. Here's how:

Pick up Voter Registration and Absentee Ballot applications from one of several locations, or ask to have them dropped off or mailed to you. Then, share them with your friends, family, coworkers, and anyone else you come in contact with – safely, of course! Do you know of any upcoming events where people will be safely gathering? Let Jo know so she or someone from her team can contact the coordinator to ask if the League could provide an opportunity for attendees to register to vote or apply for an absentee ballot. Jo will provide all necessary equipment, including forms, pens and hand sanitizer.

Jo is looking for a few coordinators to oversee specific areas for Voter Registration such as food pantries, childcare centers, and senior housing. Additionally, those coordinators will need people to help them. If you have a few hours to spare between now and early October, please contact Jo. ## Join us online for a virtual festival commemorating the 100th anniversary of the 19th Amendment's passage

On August 26 at 7:00 pm, the Facebook Live event, "Women Vote: A Centennial Commemoration," will mark the date with presentations on the history of women's suffrage, including the impact of segregation on African American women, as well as modern-day suppression in the form of gerrymandering. One hundred years of women's activism will be brought to life through presentations by the League's own Dianne Herman, Lucy Anne McKosky, and Dennis Turner. Also featured: the digitized Ohio History Connection's traveling exhibit, "Ohio Women Vote;" and digitized photos of 20 art quilts, part of the "Suffragists: And They Persisted!" collection sponsored by the Miami Valley Art Quilt Network. Songs of social justice and historical protest, from the duo Troubadours of Divine Bliss and others, will make this a captivating and informative way to mark Women's Equality Day.



This event is sponsored by Harmony Creek United Church of Christ (UCC), in coordination with David's UCC, YWCA Dayton, and the LWV Greater Dayton Area. The Ohio Humanities Council awarded a grant toward the production expenses of the "Women Vote" event.

## DECLARATION ON RACISM

LWV Greater Dayton Area, as an organization whose mission is to empower voters and defend democracy, stands in solidarity with the City of Dayton resolution declaring racism as a public health crisis. The declaration commits the city to address policies and practices that have led to the disenfranchisement of our black and brown citizens. We cannot address the fragility of our democracy without attending to those wrongs that need to be redressed.

In accordance with our support, the League pledges:

- To model and encourage civility and commit to investigating issues from multiple viewpoints.
- To remain dedicated to the advocacy work that is focused on dismantling racism within the electoral system.
- To continue to work toward just public policy so that our community can be a safe and vibrant place for all to live, work, and **VOTE**.
- To closely monitor, expose, and work to eradicate voter suppression efforts that stifle the voice of the people.
- To commit, individually and collectively, to the principles of being antiracist (persistent self-awareness, constant self-criticism, and regular self-examination).

The League honors the memories of all who have lost their lives through miscarriages of justice and systemic racism. As the League of Women Voters, we value the power of the vote to ensure real change through informed and active participation in our government. We are prepared to look at our own internal structures and find the means to work in concert with government officials and community leaders that will enable us, collectively, to pass meaningful reforms.
