

Justice O'Connor has been instrumental in leading the effort to add a citizen-led amendment to the state constitution on the November ballot. Passage of the amendment will prevent politicians, or whomever they influence, from the process of drawing legislative maps, and instead put the process in the hands of citizens. She will be answering audience questions. Help spread the word!

## LWVUS National Convention: 2024 Highlights

We enjoyed the opportunity to attend the LWVUS 2024 Convention "Turn Up and Turn Out" virtually June 27-30. Nearly 1,000 delegates from across the country, including four from Greater Dayton, voted to continue to support the Making Democracy Work campaign. Its pillars include:

- Expanding Voter Access
- Fighting Voter Suppression
- Money in Politics



Redistricting Reform

An additional "pillar" was introduced during the Saturday, June 29, plenary session. The "One Person One Vote Campaign" is a movement to abolish the Electoral College and create a new system for electing future presidents by direct popular vote. It was noted that five presidential races were decided by the Electoral College rather than by popular vote. Attendees voted to adopt a concurrence with the LWV of Washington's position on the Decline of Local News and Its Impact on Democracy, and approved a LWVUS study on federal judiciary reforms.

Other adopted program focuses for 2024-2026 include the following:

- Support initiatives promoting ethics in government at all levels
- Adopt a United Nations treaty to eliminate all forms of discrimination against women
- Reaffirm existing position for fair and humane immigration reform
- Support of public libraries as a civil right and essential for democracy
- Reaffirm commitment to reproductive rights and bodily autonomy
- Advocate for Washington D.C. to have representation in the U.S. Congress

Celina Stewart, who had been serving as LWVUS chief counsel, was selected by the Board to serve as the new CEO for her proven vision, leadership, and credibility to lead the League through transformation To see her speech describing her vision for the organization click **HERE**.

Dianna Wynn, the newly elected President of LWVUS, kicked off her presidency by stating, "A bigger, bolder, more powerful League of Women Voters can shape the future of our democracy." The goal is to grow and strengthen LWVUS at all levels by transitioning to a centralized membership process and providing resources and support to state and local leagues so the fight for democracy can be fought successfully at all levels. ## Leadership Circle Appeal



### **August 26th is Women's Equality Day**

It took over 70 years from the first woman's rights convention in Seneca Falls, New York in 1848 until the ratification of the 19th Amendment in 1920 for women to win the legal right to vote in the United States. Women were fighting for the vote in order to improve their social and economic status, with the hope that one day they would achieve gender equality. But by the early 1970s it was becoming apparent to American women that, while some progress had been

made, sex discrimination was still a major problem. Women were earning 59 cents for every dollar a man made for similar work. Harvard was still not admitting women. Sandra Day O'Connor and Ruth Bader Ginsburg were not hired in law firms despite outstanding educational qualifications. Some states were still denying women the right to serve on juries. Incredibly, women could not obtain credit cards, make wills, or own property without a husband.

During the era of social change in the 1960s and 1970s, women organized. The Women's Strike for Equality, a rally sponsored by the National Organization for Women (NOW), took place on August 26, 1970, the 50th anniversary of the passing of the 19th Amendment. There were marches, rallies and other various forms of revolt that took place in more than 90 cities and towns, making this the largest protest for gender equality in U.S. history to that point. An estimated 50,000 women marched down 5th Avenue in New York City, a group took over the Statue of Liberty and hung banners from her crown, and another group stopped the ticker tape at the American Stock Exchange while holding signs reading, "We won't bear any more bull."

As a result of the ensuing controversies and the amount of publicity, "The Women's Strike for Equality" engendered, the following year Bella Abzug, a Congresswoman from New York, successfully introduced a bill that designated August 26 as Women's Equality Day. Each year, our local League honors this legacy of fighting for gender equality to celebrate our past accomplishments and continue to work for democracy for all.


